### SUBJECT: RELEASE OF THE 2025 PROPOSED BUDGET

### 1. RECOMMENDATION:

1. That Council receive Report No. DCAO-2024-0016 prepared by the Financial Strategy and Planning Division, Office of the Deputy Chief Administrative Officer Department, dated November 6, 2024 respecting the Release of the 2025 Proposed Budget.

### 2. PURPOSE:

The purpose of this report is to release the Mayor's 2025 Proposed Budget (Budget). This information is being released to provide Council and the public with an opportunity to review the material prior to budget deliberation on December 3<sup>rd</sup> and December 4<sup>th</sup> (if required).


### 3. BACKGROUND:

On October 31, 2023, the strong mayor powers under Bill 3, Strong Mayors, Building Homes Act, 2022, were extended to the Town of Georgina. The bill extends the Mayor special powers and duties including, among others, the power to propose the municipality's annual budget, subject to Council amendments, a mayoral veto, and a Council override process as defined under O. Reg. 530/22. These specific powers cannot be delegated; however, mayoral direction may be provided to prepare a budget.

On April 24, 2024, Margaret Quirk, the Mayor of the Town of Georgina, provided the following Mayoral Direction to municipal employees:

- To prepare a proposed 2025 Operating Budget, Capital Budget and Ten-Year Capital Plan and Estimated Reserve Fund Summary that aligns with the 2023-2027 Corporate Strategic Plan, asset management plans, and with consultation with the public and members of Council; and
- 2. That a report on the 2025 proposed budget be released by addendum on November 5, 2024 for the November 6, 2024 Council meeting; and
- 3. That the 2025 proposed budget be available on the Town's website and printed copies be made available at Georgina Public Library branches on November 5, 2024.

Since receiving the Direction on April 24, 2024, town employees were engaged in the 2025 budget process as summarized in the diagram below:



Town staff ensured that the budget was prepared in accordance with Mayoral Direction and that it is made available electronically on November 5<sup>th</sup> on the Town's website and in hard copies at all Georgina Public Library branches.

Town management have provided input over the past several months in developing the Budget as presented at this time. The process has also involved reviews by the Manager, Financial Strategy and Planning / Deputy Treasurer, Deputy Chief Administrative Officer / Treasurer, Chief Administrative Officer, and the Senior Leadership Team. A summary of public comments and requests is listed under section 7 and attachment 1.

To allow sufficient time to review and provide feedback on the Budget and to align with the budget approval process prescribed in O. Reg 530/22, the deliberation of the budget was scheduled on December 3, 2024 (9:00 a.m.) and December 4, 2024 (9:00 a.m.) if applicable.

### Budget Approval Process under Bill 3, Strong Mayors, Building Homes Act, 2022

Bill 3, Strong Mayors, Building Homes Act, 2022, received Royal Assent on September 8, 2022, and was added to the Municipal Act as Part VI.1 - Special Powers and Duties of the Head of Council. On August 21, 2023, the Ontario government announced to extend the strong mayor powers to 21 municipalities, including the Town of Georgina, that have projected to have populations of 50,000 or larger by 2031, and that have committed to meeting the assigned provincial housing targets. On October 31, 2023, strong mayor powers were extended to the Town of Georgina.

The bill extends the mayors of the designated municipalities special powers and duties including, among others, the power to propose the municipality's annual budget, subject to Council amendments, a mayoral veto, and a Council override process as defined under O. Reg. 530/22. These powers cannot be delegated.

The budget approval process is described below:

- Mayor may present a proposed Town Budget no later than February 1 by providing it to Council and the Clerk.
  - If the Mayor does not present a budget to Council by February 1, Council must do so.
- Council has 30 days to pass any resolutions to amend the proposed budget, and if no amendments are presented, the Mayor's proposed budget is deemed to be adopted.
  - Council may pass a resolution to shorten the 30-day period.
- Mayor may veto Council amendments within 10 days after the time period for Council to pass amendments, with a notice of a written veto document and the reasons for the veto provided to Council and the Clerk.
  - The Mayor may shorten the 10-day time period.
- If the Mayor does not exercise the veto power, the amended budget is deemed adopted.
- Council may override the Mayor's veto (requires two-thirds majority) within 15 days after the time period for the Mayor to veto an amendment, in which case the amended budget is considered adopted.
  - Council may pass a resolution to shorten the 15-day period.
- If Council does not override the Mayor's veto, the proposed budget is considered adopted.



## 4. ANALYSIS:

### Overview

The total budget for operating and capital, which includes tax levy, water and wastewater rate, and stormwater rate supported budgets, is \$142.7 million. This includes an operating budget of \$106.4 million and a capital budget of \$36.3 million.

The Budget proposes a 2.99 per cent operating tax levy increase to ensure service levels can be maintained as the Town continues to have pressures as a result of inflation, municipal contract escalations and contractual salary pressures. The Budget includes a 2.00 per cent infrastructure levy to ensure the Town can continue to invest in the capital infrastructure that residents rely upon. This infrastructure is included in the ten-year capital plan.

The primary funding source for the operating budget is a \$58.9 million tax levy which includes the 2025 Budget proposed tax levy increase of 4.99 per cent.

These changes would translate to an average annual increase of approximately \$80.90 for the operating levy, \$54.10 for an infrastructure levy, for a total of \$135.00 (Town portion only) for a house with an assessed value of \$452,000 (average single-family detached dwelling, end phase-in assessment amount for 2024).

The water and wastewater rate supported operating budget currently includes total expenses of \$21.8 million, which includes contributions to reserves of \$1.1 million. The primary funding source for the operating budget is water and wastewater rates of \$19.8 million.

The stormwater operating budget includes total expenses of \$3.3 million, which includes contributions to reserve of about \$2.0 million. This operating budget is funded solely by stormwater rates. Through the 2025 Budget, \$1.2 million in expenditures were removed from the tax levy and transferred to stormwater. These expenditures are now fully funded by stormwater rates.

The Budget is proposing nine new permanent full-time positions, four seasonal part-time contract positions, and one request to modify an existing position from permanent part-time to permanent full-time. Only 1.5 of the proposed permanent positions have a tax levy impact while the rest are funded by rates (water/wastewater/stormwater/user fees) and assessment growth.

The Budget is proposing seven new initiatives totalling \$302 thousand of which \$82 thousand is funded by tax levies, \$50 thousand is funded by water/wastewater rates, and \$170 thousand is funded by discretionary reserves. A detailed breakdown of staffing and new initiatives is available in tab 1 of the budget book.


The Budget reflects impacts of growth-related pressures from new developments. These operational costs are funded by new assessment and are automatically added to the municipal tax roll. The Town also continues to set aside assessment growth for growth related operating expenditures relating to future capital facilities identified in the DC Background Study, such as the South Keswick Firehall. In fiscal year 2024, which provides the tax assessment base for 2025 taxation, the Town of Georgina's assessment growth recorded an increase of approximately 1.5 per cent, which is subject to any year-end adjustments from the Municipal Property Assessment Corporation (MPAC). Any year-end adjustments will be identified and addressed in the 2025 Property Tax Rates report normally issued in Q2 of each year.

There are two growth related capital projects that will be commenced in 2025 by developers. These include the Queensway North Urbanization and Terry Fox Park. Staff will bring forward separate staff reports in 2024 and 2025 for budget and DC credit approvals. The Town also applied for a grant for portions of the Queensway North Urbanization project under the Housing Enabling Water Systems Fund on November 1, 2024. Staff will report back in 2025 on the status of the grant application.

Staff have gone through, line-by-line, of every operating budget within their departments. The starting budget for 2025 is equal to the final budget from 2024. The reason why it is more prudent to start with last year's base budget, rather than last year's actuals, is that historical performance does not necessarily provide a good guideline for future performance and needs. Starting the budget based on actuals can also create a spend it or lose it culture, which has no benefit to the Town. Therefore, rather than using a year-to-date for comparison, staff have completed trend analysis by looking at the prior five years of actuals as well as existing service levels and what is required in 2025, giving consideration to economic impacts and growth, to maintain those service levels.

# **Tax Levy Operating Budget**

The operating impacts in 2025 from growth, service level increases, and inflationary pressures are listed below.



The 2025 Budget removed about 2.17 per cent from tax levies into a separate, dedicated stormwater operating budget which will be discussed later in this report.

As noted in the graph above, the most significant pressure in the Budget was related to inflationary/contractual drivers. Over the past four years (2021 to 2024) CPI Ontario has increased nearly 17%, while the Town's operating tax levy increases for the same period have only been 10%. Although the rate at which inflation is increasing is expected to decrease in 2025 to 2%, there are still inflationary pressures from previous years impacting the Town as multi-year collective agreements and operational contracts begin to renew. Anticipated increases for collective agreement renewals, IT subscription licence renewals, benefit usage increases post pandemic, insurance premium increases, utility increases, and contracted services increases are driving the 6% inflationary pressures in 2025.

To minimize the impact of the inflationary and contractual pressures on tax levies while maintaining consistent service levels, staff utilized various strategies including but not limited to:

- Utilizing various new revenue sources to mitigate tax levy pressures, such as:
  - New REC pass
  - Automated Speed Enforcement program
  - Partnership with EG for fleet services
  - User fee updates to keep up with inflation and industry norms
- Fund growth related expenditures with revenues generated from new growth at the Town
- Realign operating expenditures line-by-line to ensure that the budget requested captures the minimum required balances to maintain service levels
- Fund project managers' expenditures through the funding sources used for the
  projects they are working on. By using this funding model, the Town will be able
  to recover development charges for internal project management services, when
  they relate to growth related capital projects.

The Town continues to apply for various competitive grant programs. Grants relating to operating expenditures can be used to temporarily offset pressures, however, the ongoing impact will need to be incorporated in a future year.

### **Water and Wastewater Rates**

Council approved business case 24-CI-DCAO-03 which allowed Town staff to retain a consultant to conduct a Water and Wastewater Rates study in 2024.

The Town has initiated an update to the study prior to the five year mark due to increasing costs, a new asset management plan and a more robust non-growth related capital plan to maintain system operations. In addition, the Town's current Municipal Drinking Water Licence is set to expire in 2026 and is required to be renewed.

Hemson Consulting Ltd. (Hemson) was retained to undertake a long-term water financial plan and a water and wastewater rate study for the Town. The Study recommended increases to utility rates to fund operating costs, the non-growth capital program and also makes provisions to reserves for future asset repair and replacement.

On September 11, 2024, Council approved the Rate study as presented, subject to annual budget deliberations and bylaw approvals.

In alignment with the recently completed Water and Wastewater study, the 2025 Budget proposes the water and wastewater consumption (\$/m3) rates for the Town to be \$3.49 and \$3.54, respectively. This represents a proposed 12.5 per cent increase for the water variable rate and a proposed 4.5 per cent increase for the wastewater variable rate. The proposed water and wastewater fixed charge (\$/month) rates for the Town are \$5.77 and \$5.60, respectively. This represents a proposed 17.0 per cent increase for

the water fixed rate and a proposed 15.0 per cent increase for the wastewater fixed rate. These rates are summarized in the table below:

The above rates encompass York Region's water and wastewater rates. Note that about 56 per cent of the Town's water and wastewater budget relates to payments made to York Region.

### Stormwater Rates

Council approved business case 23-CI-DCAO-03 which allowed Town staff to retain a consultant to conduct a stormwater study focused on exploring options to assist in closing the funding gap for stormwater assets, which included the creation of a stormwater management rate, consistent with the practices taken by a number of municipalities.

A stormwater rate charge is a reliable and sustainable approach to ensuring the Town's infrastructure is in a good state of repair, both presently and for the future. Stormwater management provides benefit to all who use roads, parks, own property, and enjoy the community. In order to close the funding gap, Town staff along with Civica analyzed available revenue approaches that are currently being used by various municipalities in York Region and across Canada.

On April 24, 2024 the stormwater study was released and Council approved the general revenue approach as the funding option for stormwater. The general revenue approach is a calculation of MPAC property assessment multiplied by the approved stormwater rate for each class.

The effective start of the stormwater rate was the final tax bill for 2024. Therefore only 50 per cent of the rates were billed 2024. Starting 2025, a new dedicated Budget was created for stormwater which is fully funded by the newly created rates. To form the budget, about 2.17 per cent was removed from the tax levy supported budget which translates to about 1.2 million. As shared in the Stormwater Study, this amount was sufficient to fund only about 40 per cent of the stormwater management needs.

The 2025 Budget includes a stormwater rate increase of two per cent over the 2024 annualized rate which coincides with the recommendations of the Study. The full required amount to fund the program of \$3.3 million is being recovered through the designated stormwater rates.

Farmland (FT), Managed Forest (TT), Exempt (E) and Full payment in Lieu (CF, CG, CW, RF, RG, RP) property classes will remain excluded from the stormwater rate.

# **Capital Budget**

The 2025 capital budget is \$36.3 million. This capital program is funded through the following sources (in millions):



The updated gross ten-year capital forecast is now set at approximately \$280 million. It should be noted that the ten-year capital forecast is a fluid document that will change each year to reflect updated priorities, economic conditions, health and safety issues, and efficiencies.

The town used to have a Capital Carry Forward Policy (CS-2018-0004) which stipulated the following:

All capital projects had an automatic approval for carry forward to a maximum of two years; Any projects older than two years needed Council's approval to carry the funds forward, unless they have already been committed as part of a contract or a Council approved multi-year project.

The Capital Carry Forward Policy became obsolete when Bill 3 Strong Mayors was extended to the Town in August 2023.

Staff made significant progress in reducing the amount of carry forward projects compared to prior years and the 2025 budget proposes to carry forward all projects that have not been completed.

# **Georgina Public Library**

The Library Board has requested a grant from the Town for \$3.5 million, which represents an increase of \$190.8 thousand (5.7 per cent) in operating expenditures for 2025.

This increase is mainly due to staffing salary pressures that occurred during 2024 as part of collective agreement negotiations and non-union adjustments.

The Library Board submitted one capital request as part of the 2025 Budget to purchase Laptops for GPL Programming in the estimated amount of \$17.2 thousand. This acquisition will be funded by the Library Capital reserve.

### **User Fees**

The Budget incorporates various revenue estimates associated with user fees. These fees have been approved in various bylaws and updated throughout the past few years and include such items as the Fire department fees, the development charges fees, recreational fees, and building department fees.

The operating budget has been automatically adjusted to reflect any user fee increases that have been approved previously. In addition, fees included in attachment 2 of this report have been included in the Budget. Staff will bring forward the user fee bylaw for Council approval in Q1 and Q2 of 2025.

# 5. RELATIONSHIP TO STRATEGIC PLAN:

The Town of Georgina's 2023-2027 Corporate Strategic Plan was approved by Council on June 14, 2023. The plan outlines the priorities for the organization, ensuring a common direction and purpose for Council and staff. The new strategic plan contains five strategic areas that are key to the success of the Town's mission and specific goals. The five strategic areas are:

- Delivering services excellence
- · Ensuring balanced growth
- · Diversifying our local economy
- · Creating a vibrant, healthy and safe community for all
- Advancing environmental sustainability

To support implementation of the strategic plan, Senior Leadership met collaboratively over several months to ensure that the Budget reflects the 2023-2027 Corporate Strategic Plan.

# 6. FINANCIAL AND BUDGETARY IMPACT:

The Budget is currently proposing a 2.99 per cent increase for operating and a 2.0 per cent increase for an infrastructure levy. This would bring the total increase to 4.99 per cent for 2025. This translates into a Town increase of approximately \$135.00 per household for an average single-family detached dwelling with a CVA of \$452,000.


The Town's taxation is one of three types of property taxes paid by property owners. In addition to the local municipality, the taxes also consist of Regional and Education tax levies. The Regional and Education tax levies for 2025 are not currently known at this time. # 7. PUBLIC CONSULTATION AND NOTICE REQUIREMENTS:

Various opportunities were provided to promote public engagement and input into the budget process:

- Social media campaign and newspaper advertisements
- Budget surveys were made available online and hard copy version at the Civic Centre, MURC, LINK and all libraries; A total of 564 responses were received online and 132 in hard copy for a total of 696 responses (352 were received for the 2024 budget)
- An email address was made available for public input <u>Budget@Georgina.ca</u>
- Staff attended the Georgina Farmers Market, Pefferlaw movie night and MURC in the month of September to engage with residents
- Staff had a public open house on September 12<sup>th</sup> at the Council chambers

The chart below represents a summary of what respondents feel an acceptable property tax increase would be for 2025:




The below chart provides an overview of historical tax levy increases and Ontario CPI:

Residents were also asked to help Council determine which services should be considered a priority in the 2025 budget by indicating if they feel the service levels should be enhanced, maintained or reduced. Below is a chart that summarizes the responses that were collected.



The results of the survey revealed that residents, for the most part, are content with the services provided by the Town. The top three areas that residents asked council to prioritize for the 2025 budget were:

# 1. Economic growth, local job creation and tourism

To enhance economic growth, local job creation and tourism, the Town continues to implement the Economic Development and Tourism Strategy and Tourism Wayfinding strategy. Staff focus on investment attraction efforts by enhancing external marketing and working with The Regional Municipality of York and their team to ensure we have a presence at trade shows/conferences that attract investors in Ontario and beyond. The completion of the 1st Building in the Keswick Business Park has been a catalyst for additional investment attraction. Town staff are continuing to enhance supports to investors and are currently working with 3 tenants within the this first building to obtain permits and complete their leasehold improvements. Staff are also working closely with two landowners in the south end of the Keswick Business Park to expedite their approvals they required to get shovels in the ground.

### 2. Local parks, trails and playgrounds

 To address the need to enhance local parks, trails and playgrounds, the Budget includes a business case for \$1.2 million for the Parks Repair and Remediation Program which includes the following enhancements: cenotaph upgrades, playground replacements, picnic tables replacement, pathway repairs, dock repairs, and more. The Budget also includes the funds to redesign Willow Beach.

### 3. Road conditions and winter maintenance

 To address the need to enhance road construction and maintenance, the budget includes an investment of \$7.4 million for roads projects in 2025. The Town also continues to invest in its Roads program with projections to increase those investments annually to maintain a high standard of roads (as presented in the ten-year capital plan)

Staff also met and consulted with each member of Council regarding their priorities for the 2025 Budget.

### 8. CONCLUSION:

The 2025 Proposed Budget emphasizes the Town's investment in public services while ensuring taxpayers receive good value for their money. The Budget outlines key objectives and reaffirms the organization's commitment to sound financial management and its commitment to working together to increase housing supply. This report recommends that Council receive the 2025 Proposed Budget. Budget deliberations are scheduled for December 3<sup>rd</sup> and December 4<sup>th</sup>. Staff will bring forward the necessary bylaws for approval in Q1 and Q2 of 2025; Being, Water/Wastewater Bylaw, Stormwater Rate Bylaw, User Fee Bylaws, Tax Rates Bylaw.

# 2025 Budget - Public comments

(Organized by Major categories)

Comments were received through the Budget Survey, Public Information Sessions, and Email.

# Beaches, waterfront parks and waterfront

- I'm in favor of allowing food vendors on the beach areas, as they add a great option for residents. However, I've noticed that Weinerlicious has been setting up within the resident-only parking lot at Willow Beach, which is taking up valuable parking spaces meant for residents. This situation isn't acceptable, as it limits access to the waterfront for those of us who live here and want to enjoy our community and the amenities our taxes support. If the intention is for food vendors to set up in this area, then the parking simply needs to be expanded to accommodate both the vendors and residents. Additionally, I would like to see healthier food options available at the beach. When I spoke with the bylaw officer on duty, they mentioned that the town paid the vendor to be there. As residents, we pay for access to the parking lot and expect parking to be available to us. Please provide a better explanation and ensure that your staff are trained to communicate more effectively with residents. As part of the 2025 budget process, could you review the parking and needs assessment for the beach? I suggest considering adding more resident-only beach spaces or eliminating visitor parking altogether to better serve the community.
- I would like to see the waterfront (lake drive+) plan start coming to life. The pace of change is too slow which in some respects leads to regression if not effectively maintained. Our waterfront recreational areas are one of our main assets and it is under managed and under leveraged.
- TOP PRIORITIES: Waterfront, waterfront, waterfront. Infrastructure, infrastructure, infrastructure!!! -J.P. Harbour revitalization/rehabilitation. -Mossingtons wharf repair/replacement Acquisition of former 78 acre/with beach Mossingtons Trailer Park to retain and enhance public access. -Black River mouth dredging.
- Without knowing more about the headings above it's difficult to properly assess whether they should be increased or decreased. In general the town has a much better opportunity to better leverage our parks, green spaces, and waterfront.
- more sit down restaurants and private beach for Keswick residents only!
- Try to buy up waterfront property and convert it to public use
- Budget for more drs, beach clean up plus monitoring the beaches on wknds for people who litter and break the rules
- We need enhancements to our waterfronts with regards to public access and recreation.
   Too much is privately owned and residents cannot enjoy the waterfront we have within Keswick.

- The town needs to buy up old cottages on the water, tear them down and have water
  access for residents. Also Keswick needs a real town center, something that is like Port
  Perry, start planning it now, please put it near water, perhaps the area around 5 corners?
  Keswick has so much lost potential.
- Fix the beaches. Something like Friday harbour
- Focus on moving forward with the Waterfront Master Plan. If you build it, they will come.
   We need to drive tourism and use the profits to improve the lives of residents.
- Beaches enhanced, parking for residents expanded at beaches, sidewalks extended for safety on lake drive.
- Creation of lake front walkways, possible food truck zones etc would be incredible.
- Add a local only beach..
- Would like to see funding towards keeping beaches on lake drive safe from erosion and pollution. Keep local streets the way they are, no parking or opening to Metro.

# **Business/economic development/tourism**

- Meet with business owners in downtown Sutton so they can air their concerns regarding downtown redevelopment. In advance of rehabilitating Sutton's main street, send staff (not consultants) and Ward 4 councillor to Kincardine to find out what they had to do when they rebuilt their downtown area last year. Specifically, speak to business owners there and find out what support was given to them. What strategies did they have to survive?
- There is no need for more Municipal Law Enforcement Officers. What a waste of money. Make use of what you have. Get some more big box stores here. Get an LA Fitness, Lifetime fitness, or Goodlife fitness into this community. An active community is important. Need more convenience. Better access to healthcare/family doctors. Georgina needs to be open for business and get new businesses opened up. Out with the old, in with the new. The MURC should of had a gym and more swimming lessons for kids. Kids activities need to be prioritized. If it's not benefiting families it's not for georgina. A new civic centre shouldn't be a priority. Bigger better parks. Dump some clean sand on the beaches and make a boardwalk.
- Improve "downtown" "main st" areas in Sutton to make them more attractive to business, tourists and local residents.
- Beautification is another big opportunity to do better drive up the Queensway and give an honest assessment of how inviting this town is.
- We need to also attract commercial real estate with a new grocery store to also support the growing population.

- continue programs that supports small businesses
- Develop a shopping/restaurant area that is quaint, a walking destination by the water
- We need economic development and enhanced infrastructure
- Stop approving buildings that do not have an immediate (1 2 year) benefit to the retail industry. Require the building of industrial retail to allow for local businesses to expand, which they currently can't do because there is no industrial retail available. Building a big white elephant on Woodbine does nothing to increase jobs or promote local businesses. It's currently sitting empty with no prospect for reducing the vacancy. It's a waste and local business have no where to go but to other communities if they need to grow. Has the Town completed a study to determine areas that budgetary items can be reduced or cut altogether or just adding on to areas that don't need adding onto?
- Do something about the main street and not erect anymore eye sore buildings like across from Zehrs

- Focus on improving the overall facade and image of Georgina being a rusty town.

- Would be nice if we had a downtown area for recreational activities, bars, etc.
- I have lived here greater than 30 years. It has been very disappointing to see how the
  Town has missed the opportunity to enhance the appeal of any tourist appeal, town core
  of shops, cafes, breweries and restaurants, beautiful main streets. Every small town
  around us has exploded with yet our town has failed to entice these businesses with
  grants. We could have been Collingwood or Uxbridge with our beautiful lake and
  proximity to the GTA.
- Georgina desperately needs good paying local jobs (factory etc.) and encourage responsible employers/companies to build here to create a better tax base to relieve residence taxes.
- Put \$ into drawing new business, restaurants and services such as hair dressers to Mt
   Albert

- More independent stores rather than big box.
- More small business, more work opportunities
- I think we need to prioritize economic growth local jobs through an increase in environmental sustainability.
- the money should be well used at areas which can improve local economy, increase jobs and attract more well educated people move to Georgina
- Focus on creating jobs for our adults and new comers to allow more part-time work for our students. I've never see such a disinterest to hire students from local companies.
   Teens NEED these opportunities to build skills for their future. Part-time work increases of responsibilities by giving them a sense of purpose in their community which supports their mental health. It also, frankly, keeps them out of trouble.

# Council/staff salaries/staffing

- Reduce the monies spent on consultants by at least half
- No new hires in 2025
- Salaries, bonuses, must be reviewed and qualified. Unnecessary expenses such as trips
  that don't report back to voters on what was learned and how it will apply to Georgina
  New DEI measures that are not qulified.
- Keep salaries realistic...all other sections of our town will never realize the outrageous salary increases council receives!
- All council members take a 5% pay cut!
- Stop planning mega projects like the MURC for a long time, and high salary increases for non full time employees, like the elected PT council
- Stop spending-wages too high-too many employees

- And your 33% pay raise is completely disproportionate to the current realities of the cost of living in Georgina.
- Mayor and Council did not deserve a 33% raise

  municipality is grotesque. Why you pound salt and calcium brine to our roads like we do
  when we live near a large bed of fresh water, that just ends up in our lake, streams and
  marshes. It kills ecosystems, ruins our vehicles (that we can barely afford to drive) and
  its altering the salt content of our lake.
- Spend more on environment accessibility
- Please make our towns landscape more appealing. Plant hydrangeas everywhere . You will be amazed .. we will be remembered when you visit us!
- Can you please step up the game to make Georgina a more liveable, accessible, vibrant and environmentally sustainable community?

# Health care, housing and homelessness

- More focus on developing safe spaces for homeless and at risk Individuals to be able to go to. 24/7 shelters that can provide beds, food, resources, finances, etc. Connecting those who need it most with the appropriate care/help.
- The food bank needs more support. Majority of what's left of this "community" are starving, sick and dying because they can't afford to live in this town due to lack of resources and support. The council keeps "putting money into the town" but not the community they've done nothing to support the people
- We need to have a Hospital rather than any other recreational facility as well as train service (Go expansion)
- Basic infrastructure in Georgina is lacking no hospitals, no public transit, no Costco, poor rated schools. Not sure where the money is going right now, but these things must be fixed. Hard to raise and support a family in this neighborhood. Everything basic is at best 30 minutes away and with traffic at least an hour away. In case of an emergency, can you imagine someone will have to drive at least 30 minutes to get to a hospital?
- Help for homelessness
- Plus, we need a hospital/branch and more senior residence/nursing homes. The Town seriously needs to reprioritize actual needs and considerably reduce wants. Need to address homeless issues and warming/cooling centers. This would be a start...thank you.
- Instead of spending money on tourism, money should be spent on improving health facilities.
- Budget to provide increased services and housing for seniors.
- Mixed housing is pretty much non existent in Georgina. We need condos and smaller homes that people can buy to get into the market or downsize in retirement.
- There must be a change in what kind of development is permitted. There must be a focus on affordable housing/apartments
- There needs to be something done to reduce the impact on senior home owners to lessen the impact of these high but needed costs to stay in our homes.
- What are the health statistics for Georgina residents compared to other York Region municipalities? How do we compare for things like obesity, diabetes, heart disease? Where are the smoking cessation programs? Everyone has to drive to get anywhere, there are no trails linking communities. Are residents able to age in place? Is housing at all affordable?

# **Mayor and Council**

- The progressive changes that this council has brought in are welcome and what is needed to make the Town of Georgina a desirable and sustainable community. Great work, the MURC and Discovery library are amazing.
- Mayor and council needs to quit listening & following all of the recommendations to the technocrats within the town's staff! These budgets are totalitarian and technocratic while

ever increasing the costs to the public. There will be a tax revolt if this continues across the country. Mayor and Council should always question town staff's motives and intentions. Our town should not be a corporation for profiteering from the townspeople. The town should not be the largest employer in the town! This is an expression of bloated improperly managed budgets, narrative control & influence peddling which the Mayor and Council are guilty of. Constantly increasing the taxes is illegal and the Mayor and Council should be addressing this at every turn & opportunity! # **Property taxes**

- What have been the amounts of budget surpluses every year since 2016?
- No tax increases
- Developers should be paying to upgrade infrastructure, rather than levy.
- The cost of living has increased exponentially over the last (3) years. Rent and groceries are up nearly 40 percent. While I appreciate that raising property taxes is necessary, please remember that even a slight increase can negatively impact a family's budget. Has the Town looked at cost-saving opportunities? Families are all looking at ways to save money, and I hope the Town is as well.
- Canada's inflation rate should level off at 2.25%. Therefore Georgina's property tax increase for 2025 should be in the neighbourhood of 4%. Georgina should prioritize development; industrial, commercial, and residential. Georgina should work with the Provincial Government to speed up the 404 extension process. The highway needs to be in place prior to all Logistics/Commercial/Research and Development Centres opening within the next few years.
- Communication around service levels and taxes. It seems residents don't understand that they are related, and they expect things for free (ie. less taxes more services).
- We need to find efficiencies and cut out frills. Keeping the tax leave below the rate of inflation.
- It needs to be kept in mind that with the rising cost of gas, food, rent, etc families are already struggling an increase in taxes could mean the choice between rent and food, food and heat, etc. Town council/mayor should not need to be increasing their salaries. Sometimes cuts or maintaining costs need to start at the top. Keeping rates as they are now is most likely in the best interest of the citizens.
- No. Realize taxes will go up. We will pay. But have to cut back on something else in order to pay.

Some of these taxes are extreme considering the current economic times we are living. Some weeks its hard to feed my children and pay my bills. A a self employed, single mom this has been the toughest year in my life with no end in site just tax hikes, it makes me very sad I have had to consider leaving what I have called home since 2005. I am very disappointed for the first time in the town with additional taxes, tax hikes and more during hard times on many.
- Tax increases to support new infrastructure is unfair, inflation is hitting residents hard and we need support relating to the cost of housing and food costs.
- I'm concerned with the mandatory 2% infrastructure levy and what that is being put towards.
- It is inappropriate to suggest families should supplement the inflationary increases to overhead prior to the town taking cost saving measures.
- I just pray this council has finished the tax payers.
- Consider a cap on taxes for seniors living in their home 20+ years on CPP/OAS. It's
  unfair that the influx of new taxpayers pay the same rate as long-time residents who've
  invested a lifetime building Georgina's community. They are driving the increased need
  for services that raise our taxes, gentrifying our community and driving us out of town or
  into LTC homes.

They leave a mess that the town has to clean. However no revenue is made from the meter. Also winter they can park for free. The lot is overcrowded with outsiders. Residents cannot even access the parks that we pay for.

- Meeting spaces at The Link, MURC & Ice Palace should be cost free for community members & organizations who want to provide community events. Private bookings for parties, staff training, etc can be paid but public events should be free.
- Increase town bike and hike x country trails. In town owned forests.
- More focus on bicycle facilities (bike paths)
- More trails and local parks Not necessarily more playgrounds
- Turn the Georgina ice palace in summer months to a roller skating palace. Our youth have very little to do.
- This town to very busy and we keep paying more for less. The MURC is lacking, not a good investment. We need more programs for our school aged kids.
- Please prioritize outdoor, walkable, green spaces.
- Accessibility in parks, increase in rec programs and facilities to match the growing community.
- More focus on recreation for the kids. The MURC is a flop. Another rink, usable ball
  diamonds that are well maintained so we can host tournaments and bring in interest in
  our sports from out of town.
- Put the money to better use. The MURC was a good addition however a new arena would have been better.

- Focus on families. Make bigger better parks and water parks for kids to enjoy. Build a
  boardwalk along the water. Bring some more sand in for the beaches and keep them

  community

- Please add municipally operated fitness facility in the MURC.
- Splash pad at the Link
- Transportation is big, giving access to area's for family's and kids like parks and beaches. but still keep area's for outdoor activities, we still have a lot of people interested in biking atv-ing snowmobile water sports too. these things are slowly disappearing, it's a balancing act.
- It's appalling that in such a big community that there aren't more trails, that there is little to no fitness equipment in your rec facilities.

# **Replacement Civic Centre**

- Do not tear down the old Civic Centre...see if it can be repurposed i.e. homeless and affordable housing
- That most of our budget is going towards the new civic centre when it could go towards
  providing more jobs, as our housing is growing so there's more people but no jobs
- Get rid of that terrible idea to build a 54 million dollar Civic Centre. Save that money for what is really needed, this Mayor doesn't know how to properly take care of this city and its money. They should use existing buildings that are left vacant for in person services that the Civic Centre does. I guarantee that most of the people that "work" in the current civic centre are hybrid and barely go in. Why not use the MURC meeting rooms when in person meetings are needed. It's just plain common sense that the town can't afford to put that money into a building that is barely used. But of course this will not be read and the Mayor will still get her building because what she wants she gets and doesn't care about the town that she destroys in the process.

- It is fiscally irresponsible for you to be building a \$54 million civic centre when there are multiple buildings for sale in the \$3 to \$5 million range that would suit the needs of the Georgina town council and the staff. When we live with the staff, on the same street, kids go to the same school and we see that they work from home every single day, it is infuriating to know you're wasting \$54 million on a building that's barely gonna get used and that is very unnecessary. There are multiple departments that can function from work from home because they already are. We see them washing their cars at 2 o'clock on Wednesday afternoon, we see them going on field trips with their kids playing around. When are they working? What are we paying for already, because it feels like as a residence were paying for nothing. Cut the fat of each department, allow work from him and buy an already available building and convert it to suit the needs of the Georgina staff that have to work in the building. The rest of the \$50 mil can pay the storm water.
- There is no need for an expensive new Civic Centre building especially now with the
  economy the way it is and the budget should definitely not have funding for increasing
  staff.
- I think the new civic centre should have a town gym with full equipment and a day care.

# Roads, road safety, sidewalks

- Smaller streets don't have as much attention as the main roads. The snow needs to be plowed too and the stormwater drains and swales are always flooding in the neighbourhoods by the lake. This was the first time the drains were dug up and cleaned in 2 years I've lived here so it would be better to have that maintained more often. It would be great to have more spots for town activities and classes that are free too. It would be great to develop more for the town tourism and have shops and cafes, less warehouses.
- The third area for improvement is road safety we should better utilize one way drives, speed himps, and lane narrowing to induce slower speeds in residential areas.
- I feel traffic calming should also be rectified. The bollards that are being used are a
  complete waste of tax payer money. They only slow down inexperienced drivers, anyone
  else just speeds through or even drives over them for fun. Speed humps would be a
  much better solution, plow trucks don't need to race around the residential streets so the
  humps would not impede the trucks in any fashion. Other municipalities use speed
  humps and have had no issues with snow removal.
- Get rid of these slow down poles in the middle of the road .. they do nothing anymore .. need speed bumps or stop signs ..
- Fix the roads
- Sidewalks are very poorly maintained. They impact the use for people getting to school, work and especially seniors/ persons with disabilities. Trying to push a walker or stroller around is nearly impossible when they are not cleared. FYI, the plow has left a centre streak of either snow or salt every winter for the past 3 years. Making it so people have to walk straddled to push anything.
- My concern is snow Please keep the streets cleaned up from snow during winter (do it promptly) and during summer, please mow the grass promptly. Decrease the property tax.
- We could do with better roads not half road repair but the whole road repair.

- Streets with pot holes and ruts need to be repaved. The sidewalks on High Street are dangerous. Instead of having them grinded, they need to be removed, the ground levelled and the sidewalk put back down. Some of them need to be replaced.
- Woodbine needs to be repayed or fixed in some way and not sure how it will handle
  addition traffic from the new industry park that was build. Traffic is already bad and it will
  make it much worse (don't think it was well thought out)
- Increase sidewalk plowing. Roads were clear but I couldn't walk my son to school last
  winter. Increase garbage collection in parks. Parks are used all year. What about all
  weather trash cans? More cross walks on the Queensway. Crossing is unsafe and
  existing cross walks are too far apart. Bike lanes on the Queensway, narrowed
  automobile lanes will slow traffic, provide buffer between cars and paved shoulders.
- Sidewalk infrastructure also needs to be improved as much has been neglected.
- Road conditions need serious work, as well as more research into adding tree cover and trails. Would also love to see progress made on the now-defunct gas stations in town they need to be removed quickly and replaced with whatever is deemed appropriate for those areas, as they're awful to look at. Lastly, perhaps a town planner can consider upgrades to Dalton that make it easier to turn left out of the shops on the east side, given the increase to town population from new developments.

- We asked already many times to put a speed bumps on our street Fairbank ave at willow beach But no changes already for 2 years Also at winter time instead of using this chemical blue salt on the road has to be just sand, it's all going into the water later and we have on every corner flier, keep lake safe !!! So it's doesn't make any sense!!! Also sand it's more chipper then this chemical blue salt I called a few times to the city but no change again
- Would be great if we could have sidewalk on black river road extended down toward sibbalds point.
- On busy roads it would be a good idea to put the bollards between the bike lane and traffic.
- Rental fees for Town facilities should be lower for any non profit local event.
- Waste receptacles on the main roads, Lake Dr. and Hedge Road. Garbage is getting worse, thrown out of vehicles. As locales we pick it up, but there is nowhere to dispose of it. Additional lighting on main roads. Many now living full time and roads are dark! Baseline down to 404. (Keswick is okay) Catch basin work to continue. Builders should be responsible for adding neighbourhood infrastructure as needed for the community where built. Water/sewage, proper fencing and landscaping. Sidewalk or paths along Lake Drive by Salvation Army area due to high volume of visitors who walk all over the roadways. Dangerous.

- stop using contractors to do snow removal our sidewalks have been dangerous since
  going with contractors and when they finally do them they remove chunks of lawn and
  even go over markers set in the fall along our lawns for guidance and the snow dump at
  the end of our driveway is dangerous.
- Make sure the snow removal company takes into consideration the roads with hills before population on roads.
- The so called scenic route of lake drive N is unsafe to walk or cycle or drive a car on. Full of pot holes from Church to Orchard Beach. Heavy fire trucks should not be allowed to use unless its an emergency. Proper drainage for road would be good.
- The sidewalks down the Queensway just north of Simcoe Landing are atrocious. There is hole after hole. They are a liability.
- I'd like to see enhancements to Lake Drive to give pedestrians and cyclist protected space from cars.
- Clarity in road and infrastructure would be appreciated..I have concerns regarding the
  scheduling of shutting down High St in Sutton .. please consider the business
  there..sending them into bankruptcy seems like a very bad idea.. I also have concerns
  regarding the road end access to Lake Simcoe and what rights we will have once all of
  the surveying etc is complete.. I have been promised emails etc and none are
  forthcoming..
- Road maintenance to side roads and better snow clearance. A hold on taxes this town
  provides nothing in my area and we pay a gross amount of money. I'm 24 years the
  town has not filled the giant potholes in my neighborhood yet we pay almost \$5000. A
  year in taxes as do all of our neighbours. Ridiculous, maybe council can take a pay cut
  as over half of the town employees are close too of not making over 100,00. A year
- Metro rd tract is un walkable, culverts and ditches are full, the RoC is fantastic, water and sewer to park rd would be nice, a park or playground for missing ton would be great.
- Sutton and Pefferlaw need more town activities and programs. So many of our activitiesincluding those previously offered at the Ice Palace/Keswick Library-have been moved
  or decreased since the opening of the MURC. While the extra distance may not seem
  like much, it adds up quickly and discourages many Pefferlaw/Sutton residents from
  participating, or encourages us to travel to facilities in Durham rather than Georgina/York
  Region.
- some of the smaller town roads need to be paved, Ravenswood and DeGeer have never been paved, they were tar and chipped every 3 years until early 2000s but just patched since, roads need to have a stable base
- The older parts of town, are past due for road maintenance eg; paving and pot holes. Overhead electrical wires need to be removed and buried. Are tax dollars are being used to maintain the newer parts of town, old parts of town are being neglected.
- Operation team- Maintain ditches, for proper drainage along Ravenshoe and culverts.
- Put some money towards cleaning up the sidewalks and make homeowners trim hedges so you can walk on the sidewalks. They are embarrassing.

- Prioritize adding bike routes throughout town, including making Lake Drive East a one-way road to allow for pedestrian/bike way. Add bike lanes on Metro Road.
- The pedestrian walkway along Lake Dr N will be a welcome change but Lake Dr S in Keswick also needs a similar solution. Personally I'd prefer a sidewalk on either both sides or at least the side closest to the lake (west side) but making the road one way and opening half of it could be a more affordable solution in the short term, I just think a sidewalk is a more ideal solution. Also, and this would be a massive undertaking, but Georgina does not have great public transit to places outside of the town and I would love to see some sort of planning done to improve on that. In my opinion, the most ideal scenario is to have the GO Train split at East Gwillimbury to the east to serve Queensville, Keswick, and terminate in Sutton before heading back south. Also, we haven't heard any updates on the continuation of the 404 extending north to Highway 48?
- Please repair pot holes on Holmes Pt. and Donna Drive
- Sidewalks need to be improved and created in certain areas
- speed bumps in neighborhoods to lessen speeding

### Services and spending

# Water and wastewater/stormwater/climate change

- With climate change, dealing with storm water should be a priority. South Keswick in particular is impacted by this.
- We must take planning seriously for water culverts to storm sewers on properties that
  were designed to drain to the lake but can't due to property owners improperly modifying
  their drainage that works for their property but causes flooding to neibourbors.
- Preparing for the ongoing climate emergencies should be a key priority, as well as more supports for the growing homeless community.
