1. Climate Change Action Plan Priority Risks and Opportunities

Stephanie Wolfe, Climate Initiatives Lead, to provide results of climate hazards risk assessment and greenhouse gas inventory and present priority risks and impacts for Committee feedback.

Stephanie Wolfe provided an in-depth presentation on the priority risks and opportunities as they pertain to the Climate Change Action Plan. In terms of the project timeline, the Town is currently in Phase Four of the Climate Change Action Plan Development. To develop the risk assessment, Staff projected the status of 18 climate hazard variables to

predict climate hazard projections for 2050, and Staff utilized the Provincial Risk Assessment matrix to assess the risk of the various climate hazards. There were various engagement opportunities with the public community, Town staff, and stakeholder focus groups. Staff provided a comprehensive overview of each of the main climate hazards as well as the risks associated, organized from highest risk to lower risks, and provided an overview of data sources and metrics that were used to gather these results. Next steps include presenting the Risk Assessment results to Council on November 20, 2024, develop actions for the highest priority risks, complete the greenhouse gas inventory, and develop implementation and communication tools.

Lee Dale: Is there any synergy between what the Town of Georgina is doing and what York Region is doing?

Stephanie Wolfe: York Region has their own Climate Change Action Plan, a Health and Vulnerability Assessment, and Energy Conservation and Demand Management (carbon emissions inventory). The Town has been in communication with the Region as we are collaborating with data and metrics, and will continually consult the Region and cross reference between the Town and Region's Climate Change Action Plans. The Town will also continue to consult with the LSCRA and Public Health.

Mary-Lynn Seeley: Two other key areas to focus on would be the affects that climate change has on mental health, particularly when it comes to youth, and accessibility for the vulnerable members of the community to be able to access services such as cooling centres, and access to transportation during severe weather events.

Stephanie Wolfe: In the larger presentation slide deck, there is a section for more over-arching affects of climate change that includes mental health, and Staff have been ensuring that all plans are in compliance with accessibility standards.

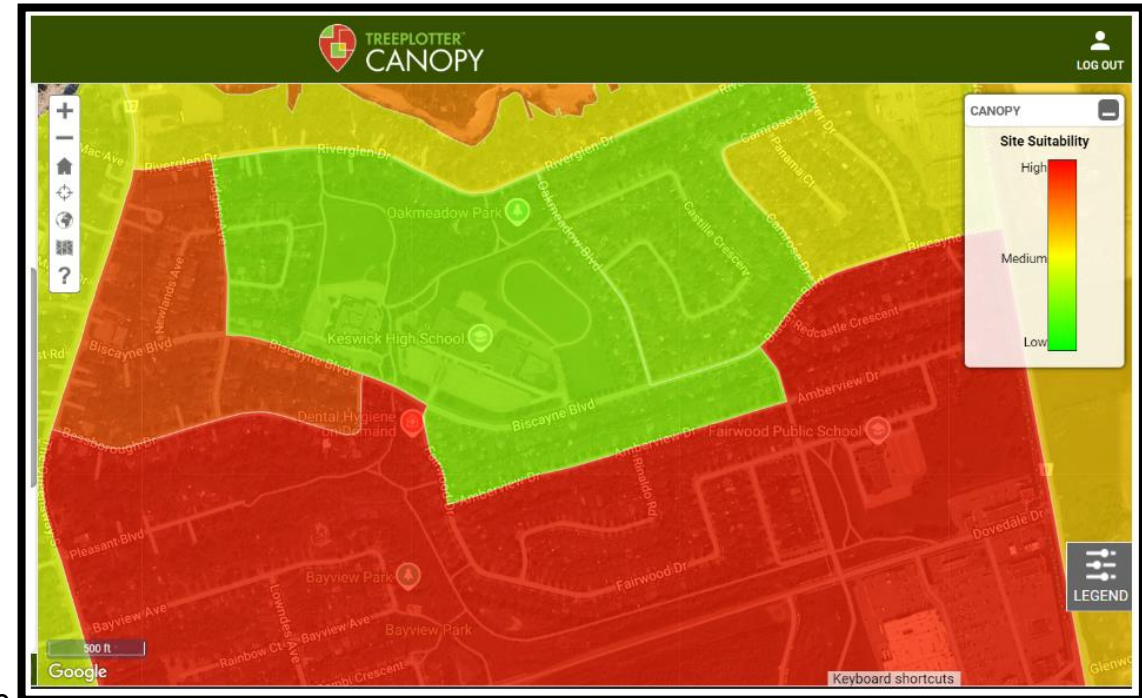
Emerald Ash Borer Capital Project

- 956 trees planted around Georgina
- Locations were selected based on where the greatest number of ash trees impacted by Emerald Ash Borer were removed
- Areas of focus include Civic Centre, Keswick subdivisions, Julia Munro Park and Pefferlaw Park



DMAF Grant

- Funding received by York Region through the Disaster Mitigation and Adaption Fund
- 186 trees planted
- Used heat mapping to select planting locations
- Areas focused on were Georgina Ice Palace, West Park, Sutton West Boulevards and Bayview Park





LEAF Community Tree Planting Event

Willow Wharf - Sept 21 & 22

- 400 native trees
- 600 native shrubs
- 175 participants over the two days





Lake Simcoe Region Conservation Authority Tree Planting Event

Willow Wharf - October 21st

- 35 participants (Development Services, Office of the Deputy CAO and Human Resources staff)
- 175 native trees
- 75 native shrubs



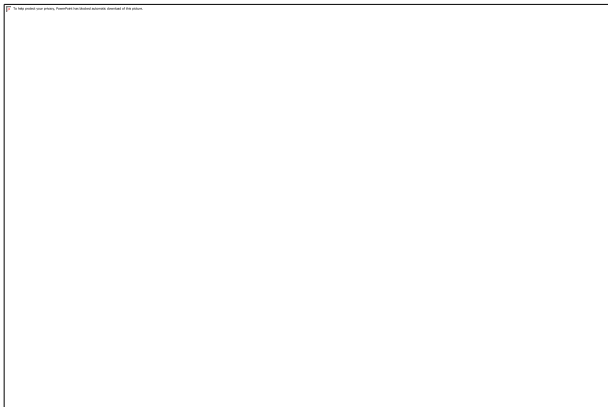


Tree Giveaway for Earth Day

Earth Day April 22nd

2,500 trees were available to be given away

- 1,990 were given to local residents
- 510 were given to 17 schools (30 trees each) throughout Georgina





2024 Overview

- 1,717 trees planted
- 675 shrubs planted
- 2,500 trees given away to local residents/schools
- 210 volunteers included in planting events
- Utilized different avenues of funding to target tree planting in various landscapes.





2025 Forecast

- DMAF Application
 - We have submitted a proposal to plant 264 trees
- Proposed \$40,000 Business Case
 - 1000 trees and shrubs through the LEAF Tree planting event
 - 45 trees for Town properties
- Trees for Life Earth Day Tree Giveaway
- Lake Simcoe Region Conservation Authority Community Tree Planting Events
