Report No. OI-2022-0014

Michael Vos provided an overview of the report.

- Staff can provide updates to Council on the program throughout the application uptake process, per ward if desired
- intention is to provide windrow service in areas where winter maintenance is currently provided by the Town, Region or Province, as the condition of roads in unserved areas is unknown
- recommended a threshold of applications based on costs to be incurred by the municipality
- validation process; accepting application in paper and online formats, random audit of applications to validate whether they can provide the required documents outlined in the policy,

anticipate a 10% audit of applications, there is a sense of honesty and trust in the program

- will add clarification to policy under service levels, fourth bullet, after '...roads not yet assumed by the Town', add 'where winter maintenance is not currently being provided'

Rob Wheater; seeking approval for \$100,000 from the stabilization reserve and staff will include into the operating budget the full cost of this program, approximately 50% of the full cost in 2023 and 50% in 2024 equating to 0.1% budget pressures in 2023 and 2024.
