BY-LAW NUMBER 2022- 0103 (COU-2)

BEING A BY-LAW TO PROVIDE FOR THE APPOINTMENT OF A PRESIDING OFFICER

WHEREAS section 242 of the *Municipal Act 2001* provides that Council may, by bylaw, appoint a Member of Council to act from time to time in the place and stead of the head of Council when the head of Council is absent or refuses to act or the office is vacant, and while so acting such member has all the powers and duties of the head of Council with respect to the role of presiding at meetings;

AND WHEREAS the Council of The Corporation of the Town of Georgina deems it desirable to provide, in the absence of the Mayor and Regional Councillor, for a Presiding Officer for the Corporation;

NOW THEREFORE the Council of The Corporation of the Town of Georgina hereby enacts as follows:

1. That each Ward Councillor is hereby designated as the Presiding Officer on a monthly rotating basis, as shown on the list below, commencing December 2022 with the Ward 1 Councillor.
