**SUBJECT: HIGHWAY 404 RESPONSE AGREEMENT – EAST GWILLIMBURY
EMERGENCY & COMMUNITY SAFETY SERVICES**

1. RECOMMENDATION:

- 1. That Council receive Report No. GFRS-2022-0002 prepared by the Georgina Fire & Rescue Services dated November 30, 2022 respecting the Highway 404 Response Agreement between the Georgina Fire & Rescue Services and East Gwillimbury Emergency & Community Safety Services.**
- 2. That Council approves of the continuation of the Response Agreement and authorizes the Director of Emergency Services and Fire Chief to execute the Agreement for a period of five years from January 1, 2023 to December 31, 2028.**

2. PURPOSE:

This report is to seek Council approval of the response agreement between Georgina Fire & Rescue Services (Georgina) and East Gwillimbury Emergency & Community Safety Services (East Gwillimbury) to continue responding to incidents on Highway 404.

3. BACKGROUND:

In 2014 the East Gwillimbury approached the Georgina to assist them in responding to emergencies on Highway 404. Council authorized this response agreement between the two departments and a Memorandum of Understanding was executed. An extension of the Memorandum of Understanding was approved in 2015.

In 2017, Council approved the executing of a Response Agreement between the two parties, this Agreement will be expiring on December 31, 2022. The Highway 404 Response Agreement, for approval is attached as Attachment 1.

4. ANALYSIS:

The continuation of this response agreement between the two departments is essential in providing effective emergency services to our residents and visitors of Georgina.

The response protocol for emergencies is in the southbound lanes of Highway 404 from the entry point off Woodbine Avenue at Ravenshoe Road to Queensville Side Road and includes the initial dispatch of one (1) fire apparatus from Station 1-4 in Keswick and the response of the Queensville Fire Station.
