**BYLAW NUMBER 2024-0005 (AD-5)**

BEING A BY-LAW TO AMEND BY-LAW NO. 2009-0011 (LI-3), BEING A BY-LAW ESTABLISHING, AMONG OTHER THINGS, LICENSE FEES FOR DOGS AND ADOPTION FEES FOR DOGS AND CATS; BY-LAW NO. 2010-0074 (AD-5), BEING A BY-LAW TO ESTABLISH FEES AND CHARGES FOR ADMINISTRATIVE SERVICES; and BY-LAW NO. 2013-0087 (PWO-5), BEING A BY-LAW TO ESTABLISH FEES AND CHARGES FOR WATER WORKS SERVICES

WHEREAS Section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, authorizes municipalities to impose fees and charges;

AND WHEREAS the Council of The Corporation of the Town of Georgina authorized at its meeting of December 5, 2023 the amendment of certain of its fees and charges through amendments to Schedule "A" to By-Law No. 2009-0011 (LI-3);

AND WHEREAS the Council of The Corporation of the Town of Georgina authorized at its meetings of January 25, 2023 and December 5, 2023 the amendment of certain of its fees and charges through amendments to Schedule "A" to By-Law No. 2010-0074 (AD-5);

AND WHEREAS the Council of The Corporation of the Town of Georgina authorized at its meeting of January 25, 2023 the amendment of certain of its fees and charges through amendments to Schedule "A" to By-Law No. 2013-0087 (PWO-5);

NOW THEREFORE the Council of The Corporation of the Town of Georgina in the Regional Municipality of York enacts as follows:

1. That Schedule "A" to By-Law No. 2009-0011 (LI-3), Schedule "A" to By-law No. 2010-0074 (AD-5), and Schedule "A" to By-law No. 2013-0087 (PWO-5) be amended to include the amended fees set out in Schedule "A" to this By-Law.

2. That any taxes applicable to the amended fees set out in Schedule "A" to this By-law shall be payable in addition to the said fees.
3. That this By-Law shall come into force and effect on January 17, 2024.
