## BYLAW NUMBER 2025-0003 (AD-5)

BEING A BYLAW TO AMEND BYLAW NO. 2010-0074 (AD-5), BEING A BYLAW TO ESTABLISH FEES AND CHARGES FOR ADMINISTRATIVE SERVICES, BYLAW NO. 2009-0011 (LI-3), BEING A BYLAW TO PROVIDE FOR THE LICENSING AND REGULATION OF DOGS, AND BYLAW NO. 2013-0087 (PWO-5), BEI

WHEREAS Section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, authorizes municipalities to impose fees and charges;

AND WHEREAS the Council of The Corporation of the Town of Georgina deems it desirable to establish certain fees and charges;

AND WHEREAS the Council of The Corporation of the Town of Georgina authorized at its meetings of December 3, 2024 amendments of certain fees and charges through amendments to Schedule "A" to Bylaw No. 2010-0074 (AD-5), schedule A to Bylaw No. 2009-0011 (LI-3), and Schedule "A" to Bylaw No. 2013-0087 (PWO-5);

NOW THEREFORE the Council of The Corporation of the Town of Georgina enacts as follows:

- 1. That Schedule "A" to Bylaw No. 2010-0074 (AD-5), Schedule "A" to Bylaw No. 2009-0011 (LI-3), and Schedule "A" to Bylaw No. 2013-0087 (PWO-5) be amended to include the fees set out in Schedule "A" to this Bylaw.
- 2. That any taxes applicable to the fees set out in Schedule "A" to this Bylaw shall be payable in addition to the said fees.
- 3. That this Bylaw shall come into force and effect on January 15, 2025.
