BEING A BY-LAW TO AMEND SCHEDULE II (NO PARKING), SCHEDULE XXV (STOP SIGNS) AND SCHEDULE XXVIII (SPEED LIMITS) OF BY-LAW NO. 2002-0046 (TR-1), BEING A BY-LAW TO REGULATE TRAFFIC AND CONTROL THE PARKING OF VEHICLES

WHEREAS the Council of the Town of Georgina may, pursuant to the Municipal Act, amend the following Schedules of By-law 2002-0046 (TR-1), which regulates traffic and controls the parking of vehicles;

BE IT THEREFORE ENACTED BY THE COUNCIL OF THE TOWN OF GEORGINA:

THAT the following be added to Schedule II, Schedule XXV, and Schedule XXVIII as set out in Tables 1, 2 and 3 respectively.
