1. Economic, Culture, and Community Betterment Grant Program

Cristina Liu, Economic Development Officer, provided an overview of the Economic, Culture, and Community Betterment (ECCB) Grant program, which continues to offer critical funding for events, programs, and initiatives that enhance Georgina's identity, culture, and economy.

Eligible applicants for the grant include not-for-profit organizations, registered charities, and businesses or organizations that promote overnight stays, contribute significantly to the local economy, and celebrate Georgina's heritage.

Applications must be submitted at least two months before the event date, and applicants are required to sign a waiver agreeing to the terms of the grant. This includes submitting detailed financial and impact reports within 90 days after the event. The Town's wordmark must also be included on all major promotional materials as recognition of the Town's financial support.

The first intake deadline is February 28, 2025, and the second intake deadline is June 30, 2025.
