**BYLAW NUMBER 2025-0019 (TR-1)**

BEING A BYLAW TO AMEND BYLAW 2023-0087 (TR-1),  
BEING A BYLAW REGULATE TRAFFIC AND TO GOVERN  
AND CONTROL THE PARKING OF VEHICLES IN THE  
TOWN OF GEORGINA

---

WHEREAS the *Municipal Act, 2001*, as amended, authorizes a municipality to pass bylaws regulating traffic and parking on highways;

AND WHEREAS it is deemed necessary to amend the Town's Bylaw 2023-0087 (TR-1) to take into account certain improvements being carried out to Lake Drive North and Lake Drive East, which are collectively known as the "Lake Drive Improvements – Phase 1";

BE IT THEREFORE ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF GEORGINA that:

1) Bylaw 2023-0087 (TR-1), as amended, is hereby further amended as follows:

(a) By adding to Part B thereof the following new Section 24.0:

24.0 Multi-Use Paths:

1. No person shall drive or operate any vehicle, except a bicycle, firetruck, police car, ambulance, other vehicle providing emergency services, Canada Post vehicle, waste pickup vehicle or Town-owned operational vehicle on the highways named in Column 1 of Schedule XXXI on the side of the highway described in Column 2 of the said Schedule between the limits of road set out in Column 3 of the said Schedule, between the times set out in Column 4 of the said Schedule.
2. No person shall stop or park any vehicle, except a bicycle, firetruck, police car, ambulance, other vehicle providing emergency services, Canada Post vehicle, waste pickup vehicle or Town-owned operational vehicle on the highways named in Column 1 of Schedule XXXI on the side of the

highway described in Column 2 of the said Schedule between the limits of road set out in Column 3 of the said Schedule, between the times set out in Column 4 of the said Schedule.

- (b) By renumbering Sections 24.0 and 25.0 of Part C thereof as Sections 25.0 and 26.0 respectively.
- (c) By adding the following Table as Schedule XXXI:

Schedule XXXI Multi-Use Paths

<b>Column 1 – Highway</b>	<b>Column 2 – Side of highway</b>	<b>Column 3 – Between</b>	<b>Column 4 – Prohibited Times or Days</b>
Lake Drive East	North	Civic Centre Road to South Drive	No earlier than May 1 or when signage has been posted, to no later than October 31 or when signage has been posted.

- (d) By adding the following to Schedule XIII (Pedestrian Crossover):

<b>Column 1 – Highway</b>	<b>Column 2 – Location</b>
Lake Drive North	Approximately 300 m north of Metro Road north (at North Gwillimbury Park)
Lake Drive North	At intersection with Sheppard Avenue
Lake Drive East	At intersection with McNeil Road
Lake Drive East	At intersection with Kennedy Road (at Willow Wharf Park)
Lake Drive East	Approximately 10 m east of intersection with Franklin Beach Road
Lake Drive East	Approximately 300 m east of De La Salle Boulevard (at De La Salle Beach)

- (e) By adding the following to Schedule XXI (Prohibited Turns):

<b>Column 1 – Highway</b>	<b>Column 2 – Between</b>	<b>Column 3 – Turns</b>	<b>Column 4 – Prohibited Times or Days</b>
Lake Drive East		Eastbound turning south to South Drive	No earlier than May 1 or when signage has been posted, to no later than October 31 or when signage has been posted.

(f) By adding the following to Schedule XXIV (Stop Signs):

<b>Column 1 – Intersections</b>	<b>Column 2 - Stop Steets</b>
Lake Drive East at Woodbine Avenue	All way stop
Lake Drive East at Civic Centre Road	All way stop
Lake Drive East at Kennedy Road	All way stop
Lake Drive East at South Drive	All way stop
South Drive at Hardwood Drive	Hardwood Drive

(g) By deleting the following from Schedule XXIV (Stop Signs):

<b>Column 1 – Intersections</b>	<b>Column 2 – Stop Streets</b>
South Drive at Hardwood Drive	South Drive (north leg)

2) This Bylaw shall come into force and effect upon its passage.
