**SUBJECT: REMUNERATION AND EXPENSES FOR MEMBERS OF COUNCIL
AND COUNCIL APPOINTEES TO LOCAL BOARDS FOR 2024**

1. RECOMMENDATION:

That Council receive Report No. DCAO-2025-0002 prepared by the Financial Controllershship and Reporting Division of the Office of the Deputy CAO dated March 5, 2025 regarding Remuneration and Expenses of Members of Council and Council Appointees to Local Boards and Committees for 2024.

2. PURPOSE:

The purpose of this report is to provide Council with information regarding the remuneration and expenses of Members of Council and Council appointees to local boards for the 2024 fiscal year, as well as fulfilling the requirement under the Municipal Act, 2001.

3. BACKGROUND:

Section 283 (1) of the Municipal Act, 2001, provides authority for the remuneration and expenses to Council, boards and other bodies.

Section 284 (1) of the Municipal Act, 2001 requires that:

“The treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,

- (a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- (b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- (c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.”

4. ANALYSIS:

This report contains schedules outlining the remuneration and expenses paid to each Member of Town Council and to Council appointees on various Local Boards, Agencies and Advisory Committees, in respect to services in 2024.
