**BYLAW NUMBER 2025-0033 (TR-1)**

BEING A BYLAW TO FURTHER AMEND BYLAW NO. 2023-0087 (TR-1), BEING A BY-LAW TO REGULATE TRAFFIC AND CONTROL THE PARKING OF VEHICLES

---

WHEREAS the Council of The Corporation of the Town of Georgina deems it advisable to amend the following Sections of and Schedules to Bylaw No. 2023-0087 (TR-1), which regulates traffic and controls the parking of vehicles;

BE IT THEREFORE ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF GEORGINA:

- 1.0 That subsection 1.0(e) of Bylaw No. 2023-0087(TR-1) is hereby amended by replacing the reference to Bylaw Number “2002-0052” in the subsection with a reference to Bylaw Number “2024-0061”;
- 2.0 That subsection 1.0(w) of Bylaw No. 2023-0087(TR-1) is hereby amended by replacing the incorrectly spelled word “temp9rarily” in the subsection with the word “temporarily”;
- 3.0 That subsection 1.0(ww) of Bylaw No. 2023-0087(TR-1) is hereby amended by replacing the definition of Waterfront Park Buffer Zone in the subsection with the following words: “means the streets included in Schedule XII to this bylaw”;
- 4.0 That subsections 5.5.4 and 5.5.5 are hereby deleted from Bylaw No. 2023-0087(TR-1);
- 5.0 That subsections 5.5.6.a, 5.5.6.b., 5.5.7, and 5.5.8 of Bylaw No. 2023-0087(TR-1) are hereby renumbered as subsections 5.5.4.a, 5.5.4.b, 5.5.5, and 5.5.6 respectively;
- 6.0 That the subsection newly renumbered as subsection 5.5.4.a. of Bylaw No. 2023-0087(TR-1) is hereby amended by adding the

words “section of the” between the words “this” and “by-law” in the first sentence of the subsection;

- 7.0 That subsection 6.0.1 of Bylaw No. 2023-0087(TR-1) is hereby amended by replacing the reference to Bylaw No. “2002-0052” in the subsection with a reference to Bylaw No. “2024-0061”;
- 8.0 That subsection 6.0.6 of Bylaw No. 2023-0087(TR-1) is hereby amended by removing the reference to subsections “6(a)” and “6(b)” in the subsection and replacing them with references to subsections “6.0.1” and “6.0.2” respectively; and
- 9.0 That the titles of Schedules I through XXX of By-law No. 2023-0087(TR-1) are hereby amended by removing therefrom the references to By-law No. “2002-0046” and replacing them with references to Bylaw No. “2023-0087”.
