1. Active Transportation Masterplan Update

Courtney Rennie, Senior Project Manager, Capital Projects – Vertical, provided a verbal update on the Active Transportation Masterplan. Courtney advised that the updated plan will guide long term investment in infrastructure that promotes active mobility. The scope for this project involved looking at the existing cycling and walking paths to identify gaps, barriers and opportunities for improvement. this master plan will ensure connectivity for future development purposes. In the fall of 2025, an online survey was implemented to study user preferences. A public information session was also provided in-person in January 2026, with a second session taking place on March 22nd hosted at the Spring Market at The Link. The final report will tentatively be ready in June 2026.
